## The United Methodist Church Committee on Faith and Order Holds Its Inaugural Meeting

The Inaugural Meeting of The United Methodist Church Committee on Faith and Order met in Arlington, Virginia, March 26–27, 2009. This committee was formed through legislation at the 2008 General Conference. Its purpose is to “give leadership to The United Methodist Church in reflecting upon, discerning and living out matters of faith, doctrinal teaching, order, and discipline in the midst of mission and ministry in the church and the world.” ¶ 1908 *Book of Discipline*.

The Committee on Faith and Order is composed of 24 members, who were nominated by the Council of Bishops, the General Board of Higher Education and Ministry, the General Commission on Christian Unity and Interreligious Concerns (GCCUIC), and the Association of United Methodist Theological Schools. Bishop Sharon Zimmerman Rader, Ecumenical Officer of the Council of Bishops, convened and presided at the meeting. During the meeting, the body elected Bishop David Yemba, bishop of Central Congo Area, the Democratic Republic of Central Congo, as its chair.

At this first meeting, the members heard four presentations: Dr. Bruce Robbins, Former General Secretary of the GCCUIC, on “Glimpses” of the History of the Faith and Order Work of The United Methodist Church; Bishop William Oden, Immediate Past Ecumenical Officer of the Council of Bishops, on the Proposal to 2008 General Conference; Dr. Stephen J. Sidorak, Jr., General Secretary of the GCCUIC, on Faith and Order/Life and Work and Church Dividing Issues; and Dr. Sarah Heaner Lancaster, Professor of Theology in the Hazen G. Werner Chair of Theology at Methodist Theological School in Ohio and Co-moderator of the Ecclesiology Working Group of the Faith and Order Commission of the World Council of Churches, on The State of Ecclesiology. The long-term service of The Methodist Church/The United Methodist Church to the ecumenical movement was noted, as well as its current involvement in the Faith and Order work of the World Council of Churches and the National Council of Churches of Christ in the USA. The historic longing for a venue to reflect theologically in an authoritative capacity within The United Methodist Church has now been realized.

The Committee elected two classes, those who will serve 2009-2012 and those who will serve 2009-2016. The members also elected six members to the Executive Committee. The Executive Committee met immediately following the adjournment of the Committee on Faith and Order to develop a reading list, make assignments, discuss ways to meet electronically on a regular basis, and to discipline itself spiritually by the creation of a cycle of prayer within its membership.
